ORDER

The UGC (Open and Distance Learning) Regulations, 2017, w.e.f. academic session beginning July, 2018 onwards, notified in the Gazette of India dated 23rd June 2017, stipulates the constitution of a Centre for Internal Quality Assurance (CIQA) to provide high quality programmes of Higher Education in the Open and Distance mode of Learning (ODL).


